A) Phalen Natural Resources Inventory (Funke)

Ms. Funke reported on the Phalen Natural Resources Inventory. CRWD in partnership with Ramsey Washington Metro Watershed District, Payne-Phalen and Dayton's Bluff Community Councils and Barr Engineering conducted a natural resource inventory for an area on the East Side of St. Paul. The purpose of this survey is to help guide community groups to protect and improve natural resources in that area.

A) CAC Reinvigoration Project Update (Eleria)

Ms. Eleria gave an update on the CAC Reinvigoration Project. Progress has slowed due to Ms. Armstead currently being on family leave, but information and evaluation is continuing. The Plan is projected to be finalized and implemented by late 2024. Manager Sullivan Janzen reflected on the board's roles as they relate to the CAC, namely, that the board's primary role is to earmark funds and provide support to the CAC through facilitating changes to reduce barriers, supporting active membership, and prioritizing CAC needs.

A) Climate Resiliency Framework (Funke)

Ms. Funke reported on the Climate Resiliency Framework. Barr Engineering has been approved to work with staff to develop a scope and budget. This scope will develop guiding principles, review climate resiliency work already done, conduct a vulnerability assessment and develop goals and actions for future work. Gwen noted that coordination with the University of Minnesota Climate Adaptation Partnership (MCAP) seemed like a natural partnership opportunity. Ms. Funke noted this, she plans to review the \$80,000 budget for this work with the CAC at a future meeting.

A) TBI Flood Mitigation / Water Quality Studies (Funke)

Ms. Funke reported on Trout Brook Interceptor (TBI) Flood Mitigation and Water Quality Studies. Twenty flood prone areas were scored. Rice Street scored the worst. Due to constraints with implementing any stormwater control and treatment projects in that area, it was decided to put in a bigger stormwater sewer pipe. The Jackson, Wheelock, Grotto and Maryland areas will be all lumped together due to impending road reconstruction. The area upstream of Gottfried's Pit was also identified as a problem area.
