V. District Initiatives for Review, Comment, and Recommendations

A) Partner Grant Program Review Update (Schwantes)

Ms. Schwantes reported on the Partner Grant Program Review. CRWD Partner Grants support programs and projects led by community organizations that share our mission to protect, manage, and improve water resources in the District. CRWD has been funding Partner Grants since 2007. It was determined that a review of the program would be beneficial, and at the Board Meeting on April 17, 2024, a review was approved. Staff developed surveys for internal and external audiences. Survey feedback was reviewed, and possible program changes were developed and presented at the September 4, 2024, Board Meeting. Recommended changes include applicants must be non-profits, projects can span two years, applicants can receive up to \$40,000, applicants would be eligible for all or no funding, new and returning applicants would qualify for the same grant amounts, and there would be 50% upfront payment and quarterly invoicing. The review results will return to the Board in early October for final recommendations.
